### Inconspicuous Admixture Dockage

10.1 - 15.0	\$0.45

Oil:	All premiums and discounts are taken to the 1/10th percentage point. All percentages are prorated.
Moisture:	Moisture above 10.0% is subject to rejection. If accepted above 10.0% discount schedule applies.
Distinctly Green:	Over 20% is subject to rejection.
Heat Damage:	Is a separate discount and will be assessed in addition to green and other damage. Over 5% is subject to rejection.
Other Damage:	Includes shruken as from frost, discolored as from mold, completely rime-covered, excessively weathered, sprouted, or otherwise distinctly damaged.
Stones:	When present, the load is subject to rejection or discount of no less than \$.23 cwt.
Conspicuous Admixtures:	Include yellow domestic mustard, pigweed, ball mustard, and inorganic material readily distinguishable from canola. Conspicuous admixtures are added to dockage.
Inconspicuous Admixtures:	Include wild mustard, domestic mustard, oriental mustard and brown mustard that is not readily distinguishable from canola. All inconspicuous admixture is added to dockage. Additional discounts apply when over 10%
Grading Fee:	A grading fee of \$20.00 per ticket will be deducted at the time of settlement.
Delivery Locations:	Canola will be handled at the following facilities only: Haven, Whiteside and Sumner County
Canola Pricing:	Canola can be priced at harvest or put on a delayed price contract. Delayed price contracts will have a \$.05/bushel/month service fee and an expiration date of January 29, 2018. Open storage will not be available.
